### I. BACKGROUND



The annual celebration of the Month of Overseas Filipinos started with President Corazon Aquino issuing Proclamation No. 276 in 1988 which institutionalized the month-long celebration every December. This is in recognition of the significant contributions of overseas Filipinos to Philippine development and the restoration of Philippine democracy.

The United Nations General Assembly proclaimed December 18 each year as International Migrants Day on 4 December 2000. On the important date, all member-states, intergovernmental and non-governmental organizations, will commence the occasion and disseminate information regarding the fundamental rights and freedom of migrants.

An Inter-Agency Committee for the Celebration of the Month of Overseas Filipinos and International Migrants Day was created through Administrative Order No. 202 issued in October 2007 by President Gloria Macapagal-Arroyo. The IAC is composed of the following members:



### 1. MIGRANT FAIR IN ZAMBOANGA CITY

November 10, 2022





The IAC-MOF and the City Government of Zamboanga successfully conducted the 2022 Migrant Fair on November 10, 2022 held at the Gymnasium of the Western Mindanao State University (WMSU), Zamboanga City. In Region 9, Zamboanga del Sur is the leading province with the most number of migrants.

More than 200 OFWs, migrant returnees and their families attended the event. The Migrant Fair was an early Christmas gift by the Philippine government and migrant civil society for them, in honor of their hard work, sacrifices and significant contributions to national development.

The kick-off activity for the 2022 MOF Celebration, the Migrant Fair is a convergence activity at the local level of migrant serving agencies and organizations headed by the Philippine Migrants Rights Watch, Commission on Filipinos Overseas, Department of Health and Overseas Workers Welfare Administration. Other participating agencies include Department of Foreign Affairs, Department of Migrant Workers/Philippine Overseas Employment Administration, Department of Tourism, Department of Trade and Industry, Department of Social Welfare Development, Department of Environment and Natural Resources, Technical Education and Skills and Development Authority, Social Security System, PhilHealth, Pag-IBIG, and International Organization for Migration.

Mayor John Dalipe of the City Government of Zamboanga fully supported the event and met with the IAC members for final preparation on November 9, 2022 at the City Hall.

Resource speakers for the event include Ms. Carmelita Nuqui of PMRW and Chair of IAC-MOF; Usec. Abdulgani M. Macatoman, OIC-Chairperson of CFO and co-Chair of IAC-MOF; Mr. Amado Natividad of the City Government of Zamboanga who represented Mayor Dalipe; and Dr. Maria Soledad Q. Antonio of the Department of Health. They hailed our modern day heroes for being partners in nation-building and encouraged the participants to avail all the services housed under one roof.

Participants, who were mostly affected by Typhoon Paeng a week prior, were happy for the whole day activity prepared for them, and queued in various booths of participating agencies and exhibitors. Services provided to them include basic medical check-up, health promotional and wellness activities, COVID-19 vaccination and booster shot, giving of vitamins, massage, manicure, pedicure, haircut, demo on baking, photo booth and consultation and frontline services from migrant-serving agencies. They were also treated to several freebies, food and raffle prizes.

OWWA Region 9 shared thru videos, inspiring stories of former OFWs who successfully reintegrated back to the Philippines and are now engaged in professional endeavors and flourishing business. They include Jopar Espino from Pagadian City, Jocelyn Barite and David Alvie Camin from Labason, Janice Tingson from Ipil, and Irene Panes from Labuan. Their experiences have touched and inspired the lives of their fellow OFWs.

DTI Region 9 and OWWA also mounted a mini Trade Fair showcasing food products and merchandise of former OFWs and their families, assisted by these agencies in setting up or upscaling their business. Exhibitors include Ruru Mushrooms by Rubylyzle Alrayes, Gab's Creation Handicraft by Shalimar Lutian, JV and Bellyn Cakes of Elaine Cruz, Jing Homemade Products by Jing Rizada, Little Treats by Rowena Eraham, Kape Larawan by Philip Enriquez and Ariel Temple, and Small OFW Business by Berkis Dacoycoy.

The event was hosted by Erwin Paul David of Pag-IBIG Fund and Vivien Potencio of OWWA.














# 2. Virtual International Forum on Migration in the United Kingdom and Ireland

**November 19, 2022** 





The IAC-MOF in partnership with the Philippine Embassy and Philippine Overseas Labor Office (POLO) London successfully conducted the "Virtual International Forum on Migration in UK and Ireland" via Zoom and Facebook Live on November 19, 2022.

With the theme "Global Compact for Migration: Hakbang tungo sa Pagsulong ng mga Karapatan ng Overseas Filipinos", the webinar was attended by members of overseas Filipino

communities in UK and Ireland. These countries are among the top destination countries of overseas Filipinos, notably healthcare workers, in Europe.

The virtual event was graced by Usec. Abdulgani M. Macatoman, OIC-Chairperson of the Commission on Filipinos Overseas (CFO); Ms. Carmelita Nuqui, President of the Philippine Migrants Rights Watch (PMRW) and Chair of the IAC-MOF; Charge d'Affaires Rhenita Rodriguez of the Philippine Embassy London; and Labor Attache Ameurfina R. Reyes of POLO-UK. They hailed our overseas Filipinos and their families for their invaluable support to Philippine development, and for their myriad contributions to the economies and societies of their host countries. They also highlighted programs and services of the government for the benefit and welfare of overseas Filipinos, including activities organized by the IAC-MOF for the 2022 MOF Celebration.

The first part of the webinar tackled the newly created Department of Migrant Workers (DMW) and programs and services of the government for overseas Filipinos. Philippine-based resource speakers under this session include Usec. Maria Anthonette C. Velasco-Allones of the Department of Migrant Workers (DMW) who discussed the thrust, programs and services of the newly created Department; Asec. Venecio V. Legapi of the DMW who discussed reintegration services of the NRCO and the reintegration roadmap of the new Department for returning/ repatriated OFWs; Mr. Vichael Angelo D. Roaring of the Department of Trade and Industry who discussed the different programs and services of DTI for OFs who want to engage in business; and Dir. Marita del Rosario-Apattad of CFO who discussed the diaspora philanthropy program of CFO for overseas Filipinos who would like to give back, volunteer or donate to the motherland.

The second part of the webinar targeted Filipinos who plan or are interested to migrate and work in the UK and Ireland. Under this session, Ms. Tanya Dewey of the Migration and Borders Group – UK Home Office and Mr. Stephen Walsh of the Embassy of Ireland discussed the Immigration system of UK and Ireland, including visa types and tips in successfully applying for a visa.

The third part of the webinar highlighted the initiatives and concerns of the Filipino community and organizations thru the presentations of Mr. Christian Estrada, Chair of the European Network of Filipino Diaspora; Ms. Irene Jagoba and Mel Morano of the Migrants Rights Center – Ireland; Mr. Ariel Lanada, President of the Filipino Nurses Association – UK; and Mr. Oliver Soriano, President of the Philippine Nurses Association – UK.

The last part of the webinar showcased the success and inspiring stories of overseas Filipinos. They include Ms. May Richell Parsons of the University Hospital Coventry and Warwickshire National Health Service Trust, and known as the Filipino-British nurse who administered world's first COVID vaccine; Dr. Cristina Juan, Project Head of the Philippines Studies of SOAS

University London; and Ms. Liza Libawan Nael, a graduate of POLO-OWWA London Livelihood Training Program and now a proud owner of Mama Liz Bakes.

During the open forum, the following questions and issues were raised – kind of assistance given to first-time migrants in the host country, process of acquiring CFO sticker by marriage migrants, reintegration program for long-time and distressed returnees, how to appeal a denied visa application, visa extension process, case of Filipino dual-citizens working in Philippine government offices, and pension and healthcare benefits for migrant returnees, among others.

The virtual participants were also treated to a soulful song rendition from Haraya Choir (Filipino Health Worker – Nurses), and colourful ethnic dance from the prestigious Bayanihan, the National Folk Dance Company of the Philippines. The latter was sponsored by the National Commission for Culture and the Arts.

The webinar was moderated by Mr. Lance Velasco of PMRW and Vice Consul Beatriz Martinez of PE London. It was attended by more than 200 estimated live viewers; and has almost 4,000 views.














### 3. MIGRANT FAIR IN CAGAYAN

**November 10, 2022** 





A day of "endless fun" was experienced by more than 200 overseas Filipinos and their families who participated in the Migrant Fair in Cagayan on December 2, 2022 at the Cagayan Coliseum, Tuguegarao City.

The event was organized by the IAC-MOF headed by the Philippine Migrants Rights Watch and Commission on Filipinos Overseas, Department of Health, and Overseas Workers Welfare Administration in partnership with the Provincial Government of Cagayan. Cagayan is the leading origin province of OFs and OFWs in the Cagayan Valley Region.

The Migrant Fair is a convergence activity at the local level of migrant serving agencies and organizations, which aim to honor and bring services closer to the migrants and their families.

The event was graced by Provincial Administrator Atty. Maria Rosario-Villaflor, representing Cagayan Governor Manuel N. Mamba, and Chief of Staff Atty. Renz Umambong representing Tuguegarao Mayor Maila Rosario Ting-Que. They thanked the OFWs and their families and hoped that migration will eventually become a choice and not a necessity for the people of Cagayan. That's why the LGU is also working hard to provide the people with necessary jobs with decent wages and livelihood opportunities, including the plan of developing "Cagayan International Gateway", so they won't be forced to leave the country anymore. They highlighted that the LGU is the national government's partner in advancing and promoting the welfare of OFWs.

IAC-MOF Chair Carmelita G. Nuqui of PMRW and co-Chair Usec. Abdulgani M. Macatoman of the CFO, DOH Regional Director Dr. Amelita M. Pangilinan and ARD Dr. Mar Wynn Bello also greeted and honored the OFs and the participants thru their respective video and actual messages.

Participating agencies which set up booth and provided frontline and consultation services and freebies, include CFO, Department of Foreign Affairs, Department of Labor and Employment, DOH, Department of Tourism, Department of Trade and Industry, Department of Social Welfare and Development, OWWA, Philippine Health Insurance Corporation, Pag-IBIG Home Development Mutual Fund, Social Security System, Technical Education and Skills Development Authority, and the Provincial Government. Participants were pampered with free hand and foot spa, manicure, pedicure, massage; given COVID-19 vaccine and booster shot, basic health services and laboratory tests; offered with vocational course scholarships, and free legal counseling; among others.

DTI also mounted a mini-trade exhibit, showcasing bags, local handicrafts, and food products of OFW families and returnees, cooperatives with OFW members, as well as indigenous people, seniors and inmates from Cagayan Valley.

To inspire OFW families to invest, former OFWs assisted by DTI and OWWA shared their success stories of reintegration. They include Ms. Susan T. Pagulayan (owner of Susan's Bakeshop in Piat), Mr. Gabriel Agustin (owner of a restaurant and catering service in Baggao),

Ms. Linda Gumiho (General Manager, Diadi OFW Multi-Purpose Cooperative), and Ms. Cristeta Ignacio (Manager, Quirino OFW Credit Cooperative).

OWWA also awarded checks for the Region 2 recipients of their financial assistance programs - "Balik Pinas! Balik Hanapbuhay! Program", "Tulong PUSO Program for OFWs", and "Welfare Assistance Program".

Participants were treated to cultural dance performances, and song numbers from Cagayan State University, CFO, and DOH. And for the finale, raffle prizes – bags of rice, health kits, agency giveaways, and home appliances courtesy of IAC-MOF members - were given to lucky winners. It was indeed a fun and meaningful day for the bagong bayani of Cagayan and their families.

The event was hosted by Mr. Deejay Lumanog and Ms. Pamela Faye Perez of DOH and Ms. Jennifer Tanguilan of PhilHealth. It's a tribute and early Christmas gift of the IAC-MOF for the migrants and their families in Cagayan.




















### 4. SSS OFW DAY



More than 80 participants attended the 5th National Conference on Migrant Health held at the Swiss-Belhotel Blulane, Sta. Cruz, Manila with a theme: "Transitioning to a Better Normal: Renewing Commitments and Building Resiliency for Migrant Health".

The Conference was organized by the Department of Health, through the Migrant Health Unit of the Bureau of International Health Cooperation, in collaboration with the Philippine Migrant Health Network (PMHN), a multisectoral collaborative body composed of members from government agencies, civil society organizations, private sector, academe and development partners.

Resource speakers include and Dr. Maria Soledad Q. Antonio and Dr. Joel Buenaventura of DOH, Asec. Paul Raymund Cortes of DFA, Asec. Venecio Legaspi and Asec. Jerome Alcantara of DMW, Ms. Carmelita Nuqui of PMRW, Dr. Renzo Guinto of St. Luke's Medical Center, Prof. Stella Go of PMRN, and Ms. Ellene Sana of Center for Migrant Advocacy.

The Conference served as a platform for PMHN members and other participants to discuss the current situation, challenges and developments relating to migration and health. The PMHN

seeks to share experience and best practices on their work to promote and protect the welfare of migrants and their families. Further, discussions include mainstreaming the Health Agenda in the Migration Sector Plans, institutionalizing a responsive and migrant-sensitive health system and lobby and advocate support for migrant health programs.











# 6. INFOMERCIAL ON DFA'S REPATRIATION EFFORTS December 13, 2022







### 7. NATIONAL FORUM ON MIGRATION

**December 15, 2022** 





The Global Compact on Migration (GCM) takes center stage during the recently concluded MOF National Forum on Migration held at the historic Manila Hotel on December 15, 2022.

The culminating event of the 2022 Month of Overseas Filipinos (MOF) and International Migrants Day Celebration, the National Forum gathered more than 200 participants and stakeholders from the Philippine migration sector, including overseas Filipinos and their

families. It was organized by the IAC-MOF led by the Philippine Migrants Rights Watch and the Commission on Filipinos Overseas, in partnership with the Department of Justice-Inter-Agency Council Against Trafficking (DOJ-IACAT).

This year's MOF theme is "GCM: Hakbang Tungo sa Pagsulong ng Karapatan ng mga Overseas Filipinos". GCM is the first inter-governmentally negotiated agreement, prepared under the auspices of the United Nations, covering all dimensions of international migration in a holistic and comprehensive manner adopted in 2018. The Philippines and the IAC members have demonstrated strong commitment to cooperate internationally to this Global Compact to facilitate safe, orderly and regular migration.

The event was graced by Ms. Carmelita Nuqui of Philippine Migrants Rights Watch and Chair of the IAC-MOF, Usec. Abdulgani Macatoman of the Commission on Filipinos Overseas, and Usec. Eduardo Jose A. De Vega of the Department of Foreign Affairs.

In their respective messages, Ms. Nuqui gave an overview of the MOF celebration and the series of activities organized by the IAC for migrants and their families in Zamboanga City, Cagayan and the UK and Ireland. She highlighted the stakeholders' responsibility in providing assistance to overseas Filipinos and making their programs and services readily available to them. Usec. Macatoman, on the other hand, declared CFO's support to the GCM, which aims to explore the ways governments can improve upon existing intergovernmental approaches to migration while keeping migrants and their human rights the highest priority. He also presented some of the CFO programs and services for migrants and their families such as PDOS, BaLinkBayan, Peso Sense Financial Literacy Program, Ugnayan with Filcom, YouLead, 1343 Actionline Against Trafficking, among others. He said that the latest pronouncement of President Bongbong Marcos urges OFWs to explore business opportunities in the country as an alternative to employment abroad and continue to contribute to the economy, especially now that the country is still recovering from the global pandemic.

The GCM comprises 23 objectives for better managing migration from the local to global levels. Attainment of these objectives were tackled by resource speakers from the government, private sector and civil society group. Usec. de Vega shared updates on the implementation of the GCM, stating that while the pact is non-binding and respects the sovereign rights of each state, the Philippines has been a GCM champion country and has strongly shown its commitment by making migration governance part of the Philippine Development Plan, and through the passage of RA 11641 or the creation of the Department of Migrant Workers (DMW). The newly created Department is now headed by Sec. Susan "Toots" Ople.

Senior Asst. State Prosecutor Lilian Doris S. Alejo of DOJ-IACAT demonstrated how the Philippines is serious in fighting human trafficking by discussing the salient features of RA 11862 or Strengthening of Anti-Trafficking in Persons Act. The law gives authorities additional

tools to battle human trafficking, particularly against the use of the internet and digital platforms to commit crimes. The Philippines has maintained its Tier 1 ranking for seven consecutive years thanks to the holistic efforts of the IACAT. This signifies that the government fully met the minimum standards for the elimination of trafficking in persons under the US government standards.

Dir. Ma. Teresa B. Capa of the Overseas Workers Welfare Administration-NCR presented AVP of the OWWA programs and services for their members and their dependents and beneficiaries.

Ms. Raquel Bracero, President of the Philippine Association of Service Exporters, Inc. (PASEI) discussed how their organization has among the best practices for the ethical recruitment of OFWs. She gave assurance that PASEI is a partner of the Philippine government in the fight against illegal recruitment and human trafficking.

Ms. Ellene Sana of the Center for Migrant Advocacy (CMA) shared the important role of civil society organizations as relevant stakeholder for social change, and their participation in the crafting and implementation of GCM – from informing, consulting, and advocating especially at the grassroots level.

To inspire OFW family participants to invest and get into business, two OFW returnees from Saudi Arabia shared their success stories - Ms. Almira Diauna now a radio announcer and owner of the agri-tourism farm site of edible fern (pako), the first in Dingalan, Aurora; and Mr. Eduardo Cortez, 2018 Model OFW Family (MOFYA) awardee who had food business and involved in outreach programs in far-flung communities in the country.

During the open forum, issues discussed include medical and health benefits for OWWA members especially for returnees and retirees, how OFs can contribute to the attainment of GCM, clarification on the new age cap set for domestic workers which is 24 years old, and how to make DFA's Report to Congress publicly accessible.

Participants were also treated to sumptuous buffet lunch, song performances, and freebies and raffle prizes courtesy of the IAC members. This is IAC's tribute for the heroism and sacrifices of our bagong bayani, who have always been dependable partners in nation-building and Philippine development.

The event was hosted by Mr. Erwin Paul David of the Pag-IBIG Fund.










On December 16, 2022, the City Government of Quezon City organized the first Migrant Fair in the City with a theme "Pamilyang OFW, May Tahanan at Kaagapay ka sa Kyusi" at the Quezon City Memorial Circle.

The first part of the program focused on capacity development orientation with a topic on Social Protection. Resource speakers include representatives from SSS, Philhealth, Pag-ibig Fund, and Center for Migrant Advocacy. Booths, participated by migrant-serving agencies, NGOs and private sector, also provided information materials and services to participants. The second part of the program was a cultural concert led by local artists Gary Granada, Peta Choir, Chickoy Pura, Bayang Barrios At Ang Naliyagan, and Ang Tao sa Tao!

An estimated 1,000 participants, composed mainly of OFW family memebrs from Quezon City attended.














### 9. FILM SHOWING OF "ANAK"

The film showing had an estimated 30 viewers.




