RESOLUTION NO. 02-2023

EXPANDING THE MEMBERSHIP OF THE INTER-AGENCY COMMITTEE FOR THE MONTH OF OVERSEAS FILIPINOS AND INTERNATIONAL MIGRANTS DAY **CELEBRATION IN THE PHILIPPINES**

WHEREAS, the Inter-Agency Committee of the Month of Overseas Filipinos and International Migrants Day (IAC-MOF) was mandated by Administrative Order 202 (2007) to take the lead in commemorating the "Month of Overseas Filipinos" and the "International Migrants Day" in December and December 18 of every year, respectively, with the end view of promoting the welfare of Filipino migrants, recognizing their role in nation-building and national development, strengthening their ties with the Philippines, and raising public awareness on various issues concerning migrants;

WHEREAS, the original members of the IAC-MOF, composed of the Philippine Migrants Rights Watch and the Commission on Filipinos Overseas as Chair and Co-Chair, respectively, with the following members:

WHEREAS, since the inception of the IAC-MOF and International Migrants Day in the Philippines, the IAC-MOF has conducted several activities such as National and International Fora on Migration, Migrant Fairs, Conferment of Migration, Advocacy and Media Awards, Film Showing on Migration, among others;

WHEREAS, during the IAC-MOF meeting of May 2, 2023, the group agreed to formalize the inclusion of migrant serving agencies and organizations who have been participating in and supporting the MOF Activities for the past years;









































WHEREAS, during also the said meeting, the Department of Migrant Workers (a newly created department responsible for the protection and promotion of the rights and welfare of OFWs and their families) concur to their inclusion in the IAC-MOF. The other agencies namely, Bureau of Immigration, Inter-Agency Council Against Trafficking Department of Justice, Department of Social Welfare and Development, and Technical Education and Skills Development Authority, have also been attending the IAC meetings and supportive of the MOF activities in the previous years.

WHEREFORE, there is a need to formally include the following agencies and organizations that also cater to Filipino migrants and their families, which were not yet included in Administrative Order No. 202 and IAC MOF Resolution 01-2014, to ensure the success of the Month of Overseas Filipinos and the International Migrants Day Celebration:
